# **Robert's Reflections**

As I stated in the June/July newsletter, that these are unusual times is certainly an understatement. The emergency COVID-19 Coronavirus pandemic has had a huge impact on our lives. Although it is now possible to dine in a restaurant, many of us are still sequestered in our homes, instead ordering food delivered from restaurants which also supports them financially.

Minnesota's governor has issued emergency executive orders, including prohibiting gatherings of large groups of people. And in my own city of Edina, our mayor issued an emergency executive order requiring that face masks be worn in common areas inside all buildings, both public and private, through the end of December. This has impacted attendance at parliamentarian conventions and meetings, of course, including having to cancel our MSAP (Minnesota State Association of Parliamentarians) Annual Convention in 2020.

But not all conventions have been canceled. The 2020 NAP (National Association of Parliamentarians) National Training Conference was held virtually: please see the reports about the training conference by Lucy Johnson and Darleen Harens on pages 2 and 3. And both the Northern Lights Parliamentarians and St. Paul Unit met in person in parking lots to amend their bylaws to allow electronic meetings, which has an additional advantage of facilitating more members, who often live at long distances, to



attend meetings via Zoom and participate in educational sessions. And the NAP Board has held its meetings virtually for some time.

But in order for the MSAP Board to have electronic meetings, we need to amend our MSAP bylaws, which can only be done by the delegates at an MSAP Convention. I am cautiously optimistic that we will be able to meet in person at our 2021 Annual Convention on Saturday, April 24<sup>th</sup>. There will be more information about the convention in the March issue. So stayed tuned . . .

# Virtual NAP Training Conference

The NAP Training Conference, held August 27-30 this year, was a first! The first time I attended this event, and the first time it was held virtually. The highlight was the reveal of the 12<sup>th</sup> edition of RONR. There were three educational sessions that discussed the changes to this latest edition. In addition, I attended several workshops and the Annual meeting during the 4-day event.

#### Welcome and RONR Introduction

Martyn Redgrave, a direct descendant of General Henry Robert, unveiled the new edition and ceremoniously retired the 11<sup>th</sup> edition. His official copy of the latest book was a bit fancier than the one I bought. He mentioned that members of the 5<sup>th</sup> generation of direct descendants are active in the Robert's Rules Association which has been a family business since 1876. Their website is www.robertsrules.com.

# **RONR 12<sup>th</sup> Edition Changes Sessions**

Three of the authors of the 12<sup>th</sup> edition led almost 5 hours of educational sessions to review the changes. To begin with, Shmuel Gerber discussed the book's physical features such as the larger size which is the same size as the *In Brief* reference. Other modifications include the sans serif font for the headings and serif font for the text. The sections are divided into paragraphs with sub paragraphs and sub-sub paragraphs. Of note, the index now contains explanatory text and better cross-references. See *casting vote* as an example.

While this was my first NAP Training Conference. It won't be my last. I was very impressed with the technology such as the use of break-out rooms (all 144 of us ended up in one of 12 "rooms" for a more in-depth discussion of a topic) and the polling features which helped to engage participants. Our own Minnesota super-star couple, Jeanette and Bob Williams, organized group photos such as our state delegation in attendance. Over 850 people attended this training.

## **NAP Conferences**

August 26 to August 30 were to be days when the MSAP members normally could have attended the Leadership Conference on Wednesday and Thursday and then the Training Conference from Friday through Sunday. This was scheduled to be in San Antonio. This year that along with many other events all of this was changed to a virtual activity instead of an inperson activity.

Nine MSAP members: Ginny Altman, Darleen Harens, Lucy Johnson, Bev Kennedy, Pat Reymann, Miriam Simmons, David Staehlin, Bob Williams, and Jeanette Williams were able to attend as it was done virtually.

During the Training Conference RONR (12<sup>th</sup> ed) was formally installed as the official current edition of RONR. Three of the authors presented the changes which were made in the 12<sup>th</sup> edition from the 11<sup>th</sup> edition. This was done over a period of over four hours in three different sessions.

Other workshops which participants were able to attend during the Training Conference dealt with many different topics. Some of the topics were: 20 Voting-Related Obstacles for New Chairs and Confused Members; Amending Bylaws; Creating a Presiding Script; Is Your Notice Sufficient; Striking a Strike; We Interrupt this Meeting; What's on Your Ballot; Considering Seriatim; and more. Hopefully those are lessons which many of you will have an opportunity to lead and/or participate in them.

Another great topic which was from the Leadership Conference dealt with Navigating RONR. Tim Wynn spent almost 2 hours showing those in attendance what was the same and what was different between the 11<sup>th</sup> and the new 12<sup>th</sup> editions. Not only did he tell the participants what was different, but then asked some questions so that members there had to open the 12<sup>th</sup> edition and find the answers. A very good way to introduce all who were there to the great way that this new edition is more user friendly.

As part of the introduction to those in attendance were told on Wednesday, normally about 50 persons sign up to attend an in-person Leadership session. This year 355 had signed up. For the Training Conference normally there are about 250 in attendance, this year as it was virtual over 800 had signed up.

What a great opportunity this was to attend these conferences while learning so much useful information.
